### **VACANCY NOTICE FOR RECRUITMENT OF CONSULTANT (FPO/FFPO) IN FIFA**

Federation of Indian FPOs and Aggregators (FIFA) is a 100% owned subsidiary of NAFED specifically focused on strengthening FPOs through capacity building, market integration and convergence of Government schemes for the benefit of FPOs. FIFA has around 800 FPO Members across the country. NAFED is acting as one of the Implementing Agencies under different Central Sector Schemes namely Formation and Promotion of 10,000 FPOs and Pradhan Mantri Matsya Sampada Yojana (PMMSY). Besides, NAFED is also implementing different Centrally Sponsored Schemes/Programs.

2. FIFA invites applications from eligible candidates on Contractual basis for the position of Consultant (FPO) at Guwahati with the following job description and eligibility criteria:

#### **3. Eligibility Criteria:**

- a. Post graduation degree in Agriculture/ Horticulture /agribusiness / Agri-marketing and related fields from a reputed University/Institute.
- b. Minimum 15 years of professional experience in Agri & allied Projects / FPO Formation and Promotion work/ Fishery based FPO formation and promotion work and other projects related to allied activities in the agriculture sector.
- c. Strong ability to build ecosystems, collaborate with stakeholders, connecting people and ability to use technology to accelerate sharing of information is essential.

#### **4. Roles and Responsibilities:**

- a. To implement and monitor the implementation of Central Sector Schemes.
- b. To conduct regular review meetings with the CBBOs and submit regular Progress Reports to the Management.
- c. To coordinate with CBBO for convergence of Govt. Schemes for setting up infrastructure for the FPO to start/scale its business.
- d. To visit FPOs and interact with FPO Members/BoDs/Staff and CBBO functionaries to monitor quality of project implementation as and when required.
- e. Regular interaction with CBBO/FPO to understand and catering to their issues, problems and services required by them.
- f. Any other activity related to FPO Business and Growth of FIFA.

### 5. Terms and Conditions:

FIFA reserves all its right to assess/amend pre-qualification and experience and short listing of candidates without any further notice. The qualification and experience shall be assessed in line with FIFA needs and the decision for selection of Consultant shall remain with the Competent Authority of FIFA. No TA/DA will be provided to applicants for interview, in case of physical interview.

6. **Location:** Guwahati, Assam.

7. **Remuneration:** The consolidated remuneration will be Rs. 80,000 to 85,000/- per month.

8. **TA/DA:** The candidate shall be allowed to take domestic tour as per requirement for which TA/DA and accommodation shall be as per FIFA policy.

9. **Period of Contract:** The appointment is of contractual in nature initially for a period of one year. The renewal of contract period is subject to satisfactory performance and requirement of FIFA.

10. **Termination of Contract:** FIFA reserves all the right to cancel the contract at any time without providing any reasons for it. However, normally one month's notice is needed from either' side.
